Accompanying Persons Tour – Ostia Antica USD 110

Ostia Antica is a large archaeological site that was ancient Rome's seaport and one of the most thriving cities in the region. It served as Rome's main seaport during the Roman Republic (509 BC - 27 BC) and was largely improved by Julius Caesar and Tiberus during the Roman Empire. After the collapse of the Empire, the city fell into decadence and was eventually abandoned and remained untouched and preserved for centuries.

The site still houses the remains of most of the buildings before it was abandoned. You can still see houses, shops, taverns and a theatre and get a feel of what life was like in this bustling city 2000 years ago.

Following the guided tour of Ostia Antica, guests will enjoy lunch before returning to the hotel. Dress: Casual; **Bus begins loading at 8:50 a.m.** and leaves at 9:00 a.m.
